Aside from boosting the morale of police personnel in the aftermath of the inaugural Transforming Our Police Service (TOPS) Competition last year, the PCOA unquestionably achieved its main objective hosting the competition, that of fostering greater conformance with prescribed Jamaica Constabulary Force policies, especially as it pertained to the management of records.

This was manifested during the quarter when the PCOA Team returned to re-inspect 32 stations in the three divisions - St. Mary, Portland and St. Ann - which comprise Area 2.

The re-inspection is the last of the four layers of the Accountability Framework Initiative, which includes the initial inspections for the TOPS competition; awards ceremony and incentive; and, meeting with the Area hierarchy to agree upon deliverables and hold divisional commanders.

Findings from the inspections revealed that a minimum of two stations in the three divisions attained perfection in the maintenance of all the major records inspected, which was far from the case in the inspections for the For TOPS Competition. the St. Ann Division, the most notable improvement was in the maintenance of the Station Diary, which moved from 18% to 54% the number of stations

properly maintaining this record. In fact, more than half of the eleven stations maintained records correctly unlike the situation in 2019. All stations also adhered to JCF policies when maintaining the CR-10 record.

The St. Mary Division reflected similar improvement especially with the historically problematic Station Diary, where the number of stations went from 0% to 36% in terms of adherence to JCF policies. All stations properly maintained the Firearm Register and CR-10 records, which again was the antithesis of 2019. This division also had the most improved station in Area 2 as the Castleton Station moved from maintaining 25% of the records inspected to 100%. As for the Portland Division, there was an improvement in adherence to JCF policies in the keeping of all records, particularly the Station Diary. Overall, the Top Stations in three divisions (San San, Portland; Bamboo Station, St. Ann and Gayle, St. Mary) maintained excellence in the management of their records.

PLANS ARE UNDERWAY TO LAUNCH 2020 TOPS **COMPETITION IN THE NEXT QUARTER**

The Jamaica Constabulary Force (JCF) Area 5 has been selected for the next staging of the Transforming Our Police Service (TOPS) Competition.

The competition, which is now in

its second year, is aimed at fostering greater conformance with prescribed JCF policies as well as raising morale among police personnel. "It is our view that the initiative, which was launched last year, was a successful one and after much consideration, the Flyer for the 2020 TOPS Competition. PCOA Members took

the decision for it to be an annual event," PCOA CEO, Otarah Byfield disclosed.

Inspections in Area 5 will be conducted in October, covering four divisions - St. Catherine North, St. Catherine South, St. Andrew North and St. Thomas - which

Inspections will focus on some key areas, which include: Records Management, Station Administration, Station Facility and Community/Customer Service. Winners of the various categories - Top Divi-sion, Top Station and JCF AREA 5 COMPETITION

St. Andrew JCF Divisions Score High Marks for Implementation of COVID-19 Measures

Findings from a special inspection of JCF Divisions in the parish of St. Andrew to assess the safety measures implemented in the wake of COVID-19, for the most part indicate that, the divisions were more than adequately prepared. The inspection was conducted in June, covering three divisions - St. Andrew Central, St. Andrew South and St. Andrew North, comprising of 20 stations. However, the August Town Station was not inspected due to unrest in the area. The divisions scored high marks in the majority of the areas inspected. Among those areas include: a 100 per cent of the stations implemented adequate measures to encourage social distancing; 95 per cent of the stations implemented meas-

ures for the public to have access to a wash or sanitization area; the wearing of mask upon entry, was enforced in 89 per cent of the stations inspected; 89 per cent of the stations sanitized at least twice a day as required by guidelines; 86 per cent of the lockups identified a decontamination zone to sanitize items before they are issued to the prisoners; and, 84 per cent had the required supplies of personal protective equipment (gloves, disposables, masks and hand sanitizers).

Also commendable was the concerted effort in several stations across the divisions to educate visitors to stations about COVID-19 guidelines via posters on walls and notice boards.

Meanwhile, there were two areas which required attention. One of which revolved around the adequacy of cleaning agents, whereby only 63 per cent had sufficient bleach, soap and liquid disinfectant. The other, highlighted that only 32 per cent of the stations inspected, mentioned COVID-19 guidelines in all their briefings as required by force policy.

So far, COVID-19 inspections have been

Majority of Stations in Area 2 Divisions Meet COVID-19 Requirements

During the quarter, special inspections focusing on the safety measures implemented at stations in Area 2 in the wake of COVID-19 were conducted concurrently with Area 2 post Transforming Our Police Service (TOPS) Competition re-inspections.

The Ministry of Health and Wellness reported in August that Portland, St. Mary and St. Ann divisions, which comprise Area 2, collectively had 141 cases of COVID-19 with St. Ann having half the amount. In comparison to the number of cases in the hotbed parishes of St. Catherine and Kingston and St. Andrew in particular, the collective number of cases were not as alarming. The inspections, however, were timely due to the spike in cases, which was expected to follow elections scheduled for September 3. "It was imperative for us to determine the level of preparedness of police personnel for the pending increase in cases. We needed to know that they had adequate measures to mitigate against the spread of the virus while they conducted their duties," said Senior Director, Inspections and Monitoring, Andrew Beaumont.

The inspections revealed that overall, the majority of the stations had implemented safety measures to protect against the spread of the virus.

The most impressive were the 9 stations in the Portland Divisions, as they all met the requirements for the sanitization of

of the physical plant; the provision of a sanitization area for persons visiting the station; measures to encourage social distancing and; the enforcement of the wearing of masks on the station compound. In the St. Mary Division, all 11 stations were up to par regarding the sanitization of the physical plant, which was at least twice a day, and also the provision of a sanitization area for the public to access. Ninety-one per cent of the stations implemented adequate measures to encourage social distancing, while only 73 per cent of the stations were observed enforcing the wearing of masks in the station.

As for the 11 stations in the St. Ann Division, only 64 per cent adhered to the requirement regarding the sanitization of the physical plant, while 91 per cent of them made provisions for a sanitization area for the public to access. In regards to measures to encourage social distancing and the enforcement of the wearing of masks upon entering the facility, all stations met these requirements.

cords management among other areas.

The areas representing a slight challenge throughout the divisions were: the adequacy regarding the supply of personal protective equipment (PPE) and the availability of sufficient cleaning agents. With the exception of stations in the St. Mary Division, 55 per cent of the stations in St. Ann and 78 per cent of the stations in Portland had an adequate supply of PPEs. With regard to the supply of cleaning agents not all stations had a sufficient amount in the divisions - 91 per cent of the stations in the St. Mary Division; 89 per cent of the stations in the

Portland Division; and, 82 per cent of the stations in the St. Ann Division. The disinfectant sprays available were all past their expiration date.

As it related to the implementation of Prisoners in Custody (PIC) protocols for the most part, thermometers were available at all PIC stations to conduct body temperature checks and all lock-ups met the

requirement pertaining to the sanitization of cells, the minimum of which is thrice weekly.

JCF Secretariat to the PCOA Revitalized

preliminary protocols of operation and engagement between the two.

"The purpose of the JCF Secretariat was to establish a channel between the JCF hierarchy and the PCOA, in order to more efficiently address concerns of the PCOA and the JCF," the PCOA CEO stated. Coming out of the

meeting, an agreement was made that all Inspection Reports emanating from the PCOA would be disseminated to the JCF Secretariat, through the Chairman, with a view to discuss and engage the Commissioner regarding findings in the reports. "This will be done after Area and Divisional Commanders are given an opportunity to respond to any concerns in the report," Ms. Byfield expounded. The PCOA also committed to highlighting the concerns when observed and seeking interventions in resolving matters.

The Chairman was also updated on the activities of the PCOA including the inspections conducted during the quarter and the concerns regarding the current challenges and health risks that COVID-19 presented.

For his part, the Chairman reinforced the support of the JCF Secretariat in facilitating the work of the PCOA.

The Secretariat was the brainchild of the former Commissioner of Police, Dr. Carl Willimas, who established the group in December 2015 in order to be kept abreast of outstanding issues relating to PCOA concerns and also deliverables in respect to addressing these concerns.

Meetings between the Secretariat and the PCOA will be held quarterly.

Community Newsletter Launched

In a drive to further connect with our stakeholders in the wake of COVID-19, the PCOA launched a quarterly community newsletter, entitled the *Citizen Corner* during the quarter. The newsletter, which is available in hard copy, was disseminated to Police Sta-
