OVERVIEW

An inspection of the JCF St. Catherine South Division was conducted by the Police Civilian Oversight Authority between May 22-28, 2024. Police stations in this Division are located at Bridgeport, Caymanas, Central Village, Portmore, Hellshire, Old Harbour, Old Harbour Bay and Waterford.

Station Records Examined

Station Diary – Records all activities at the station such as staff deployment, reports and should be cross-referenced with other records at the station.

Firearm Register – Records the movement of firearms and ammunition issued.

Customer Service Reference Form (CR10) – keeps a record of all reports from the public.

General Property Book – Records all property in custody at the station including motor vehicles in accidents.

Sudden Death Register – Records all deaths reported.
